# **Accountability**

- Effective and timely support is provided to the formulation of a clear and coherent protection and solutions oriented PSS strategy which is based on an age, gender and diversity analysis and reflects the Organization's global, regional and country level priorities.
- The participation of persons of concern is assured through continuous assessments and evaluations using participatory, rights and community-based approaches, which inform protection and assistance programming and ensure that UNHCR meets its commitments to accountability to persons of concern.
- National protection capacities are improved in PSS prevention and response through direct engagement, research and advocacy with all relevant external interlocutors.
- PSS needs are immediately identified and addressed through direct intervention, advocacy and public exposure.

# **Duties and Responsibilities:**

- Establish and maintain a network with national and international NGO partners and communities of concern, as well as government and other stakeholders, to develop community-owned strategies to address psychosocial needs.
- Oversee mapping and analysis of psychosocial risks to communities of concern as well as their capacities and resources for community-based and self-support initiatives in PSS.
- Coordinate the PSS response across relevant sectors and working groups, and ensure its mainstreaming into relevant activities in line with the IASC MHPSS guidelines and the overall protection strategy.
- Ensure close cooperation with the Health Unit which is responsible for the mental health response.
- Provide technical guidance and support to field offices, focal points on PSS and general protection staff as well as partners.
- Ensure that psychosocial activities are integrated in programme formulation at the agency and HRP level.
- Contribute to the development of PSS operational guidelines and tools, set relevant standards, and disseminate PSS material to support field offices in monitoring PSS activities.
- Organize regular field missions to monitor and evaluate the implementation of community-based PSS activities and ensure their conformity with participatory, community-based and age, gender and diversity approaches.
- Provide periodic qualitative and quantitative reports, analysis and recommendations related to PSS.
- Participate in building the capacity of PSS focal points in field offices and among partner staff by designing and facilitating capacity building activities on PSS subjects.
- Undertake other related tasks as requested by the direct supervisor.



# **Authority**

- Contribute to the development of a community-based protection strategy in the area of PSS, project submissions and the budget for endorsement by the Assistant Representative (Protection) or the Representative.
- Chair meetings on PSS topics with partners.
- Intervene with authorities on PSS-related issues.
- Negotiate with local counterparts, partners and populations of concern.

#### **Education and Skills:**

- Education: Undergraduate degree (equivalent of a BA/BS) in International Development, Human Rights, International Social Work, Psychology, Sociology, Anthropology, or other clearly related disciplines.
- Very good knowledge of local language and local institutions.

- Minimum 1 year professional experience in community services, PSS, social work or/and human rights or related responsibilities in the government, NGO or international organisations.

#### Languages:

- Fluency in English and Arabic.
